INTRODUCTORY WORD

2021 was the year of humanity's full adaptation to work during the pandemic. Many events began to be held in a hybrid format, which on the one hand provided an opportunity to convey information to the general international public with minimal resources, and on the other hand, such a format limits the possibility to expand one's circle of friends.

2021 saw a continued systemic restructuring of the organizational development of the Crimean Tatar Resource Center (CTRC). CTRC has improved its management, modernized its accounting and changed the architecture of its website.

In 2021, the «Strategy of the Crimean Tatar Resource Center» was revised, analyzed and extended until 2023.

CTRC systematically updates its clickable diagrams «Victims of the occupation of Crimea», which are always available on the organization's website in 4 languages and reflect the current number of Kremlin prisoners, missing and killed during Crimea's occupation.

CTRC classified and developed a clickable diagram «Classification of people, responsible for human rights violations in the occupied Crimea», which is always available on the organization's website and displays lists of persons who violate human rights in Crimea according to their professional activity.

CTRC has developed a Methodology for assessing the expediency of introducing personal sanctions against persons who cooperate with the occupational administrations of the Russian Federation on temporarily occupied territories, and used

it as a base to develop the «Will you fall under sanctions?» test. Residents of occupied territories can use it to assess the level of their collaboration, whether they violate Ukrainian laws and will be prosecuted. This technique was recommended for the development of a draft law of Ukraine on transitional justice, and also provides the possibility of introducing sanctions by the National Security and Defense Council of Ukraine, international organizations and countries against persons whose activities harm Ukraine. This methodology was presented to the embassies of the member states of the Crimean Platform.

In 2021, the Crimean Tatar Resource Center developed its communication strategy that helped to introduce changes to approaches to content formation, which allowed to increase the number of followers on the organization's social network pages.

2021 saw the development of a fund-raising strategy, with which the organization hopes to improve its financial situation in 2022.

In 2021, the Crimean Tatar Resource Center began work on obtaining observer status under the UN Framework Convention on Climate Change (UNFCCC).

Our priorities remain the same: ensuring the collective rights of the Crimean Tatar people and the individual rights of all residents of Crimea; implementation of human rights activities; development of draft legislation and regulations; support of cultural and educational initiatives; conducting of monitoring and analysis of the components of Crimea's sustainable development; implementation of informational and educational activities.

In 2021, an important event for all Crimean residents took place - the adop-

tion of the Strategy for the De-occupation and Reintegration of the Temporarily Occupied Autonomous Republic of Crimea and the city of Sevastopol, and for the indigenous peoples of Ukraine, the adoption of the Law of Ukraine «On Indigenous Peoples of Ukraine», which the Crimean Tatar Resource Center has advocated for many years. In 2021, together with the State Service of Ukraine for Ethno-politics and Freedom of Conscience CTRC started work on its implementation, and three legal acts were developed.

We are focused on achieving the strategic goals of the Crimean Tatar Resource Center through our institutional programs, actions/campaigns and events formed during the Center's strategic sessions and focus groups.

This is exactly the approach that guarantees an effective enforcement of human

rights, deoccupation and reintegration of Crimea. Together with the expert community, we managed to highlight the main directions for the implementation of innovative creative projects and advocacy campaigns, taking into account the interests of different audiences. Also, such a program approach ensures transparent management of funds, solving specific tasks and achieving measurable results.

In 2021, CTRC continued communicating with diplomats and parliaments of various countries regarding the recognition of the deportation of the Crimean Tatar people in 1944 as an act of genocide.

We learn together with you: while organization the Academy of Public Diplomacy of the Crimean Tatar people, the annual international summer camp «Freedom Camp», human rights seminars and training sessions, the CTRC team worked on

improving its activities, strategic planning and developing of new creative advocacy campaigns. We are grateful to everyone who believes in the Crimean Tatar Resource Center and assists us, our friends, experts, and partners.

I am grateful to the Crimean Tatar Resource Center team, whose energy and effort are really impressive. Together we shape the future of our country, our common values, continue a non-violent struggle for the deoccupation of Crimea and protect the rights of our citizens.

ABOUT CTRC: MISSION, VISION, VALUES, GOALS

1.1. OUR MISSION

The Crimean Tatar Resource Center is a non-governmental organization that works at the local, national and international levels, aimed at the non-violent de-occupation, reintegration and sustainable development of Crimea through the protection of human rights, implementation of the collective rights of the indigenous peoples on their historical homeland, monitoring and analysis of the components of sustainable development of Crimea, support for cultural, educational, scientific initiatives, information and educational activities.

1.2 OUR VISION

The activities of the Crimean Tatar Resource Center have become a component of the de-occupation of Crimea. The results of the work of the Crimean Tatar Resource Center contributed to peaceful coexistence of representatives of different ethnic groups and religions, protection of rights of indigenous peoples and human rights, sustainable development of Crimea in Ukraine and strengthening its democratic institutions. The activities of the Crimean Tatar Resource Center led to an objective perception of the Crimean issue at the global and European scale.

CTRC'S ORGANIZATIONAL STRUCTURE AND ORGANIZATIONAL DEVELOPMENT

The highest governing body of the Crimean Tatar Resource Center is the **GENERAL MEETING**, which currently consists of 37 members. Its mandate includes the adoption of strategic decisions regarding the organization's activities, as well as the formation of the Supervisory Board and the Managing Board. They meet once a year.

THE SUPERVISORY BOARD is a collective body that supervises activities of the Managing Board. It is elected by the GENERAL MEETING and consists of 5 people. Members of the organization do not have the right to be elected to the Supervisory Board. It meets no less than once a year.

THE MANAGING BOARD is a governing, permanent collegial body. It consists of the Head of the Board and members of the Board. The Board is elected by the GENERAL MEETING for a period of 5 (five) years and includes at least 5 persons. The Board, headed by the Head of the Board, participates in the development of the Strategy and coordinates the organization's current activity.

SPECIALIZED EXPERT COUNCILS are consultative and advisory bodies that are formed on a permanent or temporary basis to carry out expert evaluation and provide recommendations and proposals that contribute to the achievement of the organization's goals. The decisions on the formation or liquidation of an Expert Council, its quantity and personal composition are adopted at the meeting of the Board. Today, there are two Expert Councils within the structure of the Crimean Tatar Resource Center: the Legal Expert Council and the Expert Council on environmental protection and sustainable development of Crimea.

In 2020, the position of the **EXECUTIVE DIRECTOR** was introduced within the organization as a permanent executive body. The Executive Director is appointed to the position by the Head of the Managing Board with the Managing Board's consent. The competence of the executive director includes: management of current projects; management of staff employees; implementation of activities within programs and projects in accordance with approved plans and budgets; ensuring the accountability of employees to the statutory management bodies, and the implementation of internal regulatory documents.

CTRC has a **NETWORK OF VOLUNTEERS AND ACTIVISTS** both in Ukraine and abroad. One of the priority directions of the organization's activity is cooperation with the V.I. Vernadsky Taurida National University, which was transferred from Crimea. Students

of this higher education institution regularly undergo internships at CTRC, and are volunteers or employees of the organization.

In its activities, the Crimean Tatar Resource Center is guided by the **ORGANIZATION'S STATUTE**, internal provisions, rules and procedures. Each employee of the organization has his or her own job description. In 2021, the Organization's budget and audit policy were developed.

Within CTRC's organizational development, the **«CRIMEAN TATAR RESOURCE CENTER STRATEGY»** was revised. The organization has developed a communication strategy and started work on a fundraising strategy. In its activities CTRC uses software for system management and project management.

From July 2020 to July 2022 the organization's employees passed an educational program within the framework of the main institutional grant of the Initiative for the development of environmental policy and advocacy in Ukraine.

Also, the organization's employees regularly participate in trainings in accordance with their line of work to improve their competence and qualifications.

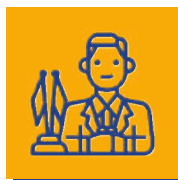

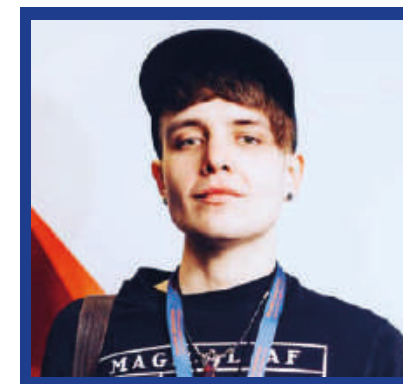

REPORT ON ACTIVITIES IN 2021

6.1. PROTECTION OF HUMAN RIGHTS IN THE OCCUPIED CRIMEA

In order to protect individual rights, in 2021 CTRC continued to carry out systematic monitoring of human rights violations in the occupied Crimea, based on which a monthly, quarterly and annual «Analysis of human rights violations in the occupied Crimea» was published. A total of 16 analyses were prepared during the year.



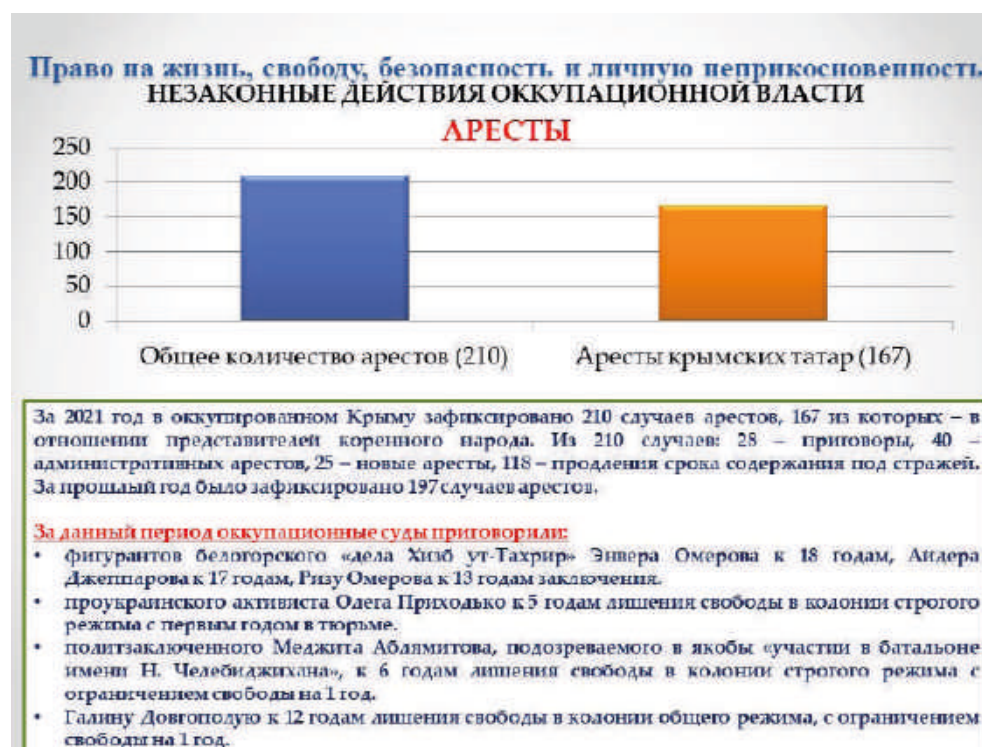

ANALYSIS OF HUMAN RIGHTS VIOLATIONS IN THE OCCUPIED CRIMEA

The collected material also became the basis for preparing and submitting relevant statements, appeals and reports to universal and regional human rights protection mechanisms. In 2021, CTRC submitted 8 applications and reports to international organizations including 3 reports to UN special procedures and a report to the UN Committee on the Elimination of Discrimination against Women.

CTRC continued to cooperate with the state authorities of Ukraine in order to ensure the rights of Ukrainian citizens in the occupied Crimea. Among them are the Main Office of the National Police in the ARC and Sevastopol, the ARC Prosecutor's Office, the Department of International Police Cooperation of the National Police of Ukraine, Ministry of Foreign Affairs of Ukraine, Ministry of Reintegration of the Temporarily Occupied Territories of Ukraine, Ministry of Culture and Information Policy of Ukraine, Ministry of Environmental Protection and Natural Resources of Ukraine, Ministry of Education and Science of Ukraine, State Water Resources Agency of Ukraine, State Ecological Inspection of Ukraine, State Fisheries Agency of Ukraine, State Forest Resources Agency of Ukraine, State Emergency Service of Ukraine, Ministry of Defense of Ukraine, Permanent Mission of the President of Ukraine in the Autonomous Republic of Crimea and others.

Переслідування корінного кримськотатарського народу в окупованому Криму під виглядом боротьби з тероризмом

З 2014 року, початку тимчасової окупації Криму, Російська Федерація розпочала активну боротьбу з «тероризмом» і «екстремізмом». Насправді це є інструментом придушення ненасильницького опору кримських татар - корінного народу Криму, які сповідують іслам, які виступили проти окупації своєї Батьківщини. Окупаційна влада розпочала кампанію з їх переслідування і формування образу «внутрішнього ворога», використовуючи мову ворожнечі, порушуючи фундаментальні права людини і колективні права, зокрема корінного кримськотатарського народу.

Росія, застосовуючи власне кримінальне законодавство на окупованій території, порушує ст. 64 IV Женевської конвенції про захист цивільного населення під час війни від 12 серпня 1949 року. Паралельно з цим, застосування російського законодавства на окупованій українській території тягне за собою введення обмежень для громадян України в реалізації свого права на свободу думки. Наприклад, в російське законодавство введена кримінальна відповідальність за заперечення приналежності Криму до Російської Федерації, дані дії відповідно до російського законодавства кваліфікуються як екстремізм.

Найбільш поширеним інструментом боротьби з кримськотатарськими та українськими активістами, які виступають проти дій де-факто влади в Криму, стало порушення кримінальних справ за ст. 205.5 КК РФ (Організація діяльності терористичної організації і участь в діяльності такої організації). На сьогодні, за нібито участь в організації Хізб ут-Тахрір 31 особу засуджено на термін від 7 до 19 років колонії суворого режиму, 44 людини перебувають у СІЗО і чекають вироку, 3 людини відбули покарання у вигляді 5-ти років позбавлення волі в

Рекомендації для де-факто влади в Криму:

- припинити практику застосування власного кримінального законодавства на окупованій території;
- утриматися від криміналізації і адміністративного переслідування дій, направлених на вираження власного мненія;
- зняти обмеження на доступ до інформації.

CTRC advocates the adoption of laws similar to the Magnitsky Act in Western countries, as well as the possibility of applying similar laws in countries where it has been adopted to people involved in human rights violations in the occupied Crimea.

In 2021, CTRC prepared and handed over a list of 50 people involved in human rights violations in the occupied Crimea to representatives of countries that have laws similar to the Magnitsky Act with a request to include them in the sanctions lists - USA, Great Britain, Canada, Estonia, Latvia, Lithuania and the EU. Five meetings were held with the embassies of foreign countries regarding this issue.



CTRC SANCTIONS LIST

In many countries, personal sanctions have not yet been imposed on persons who violate human rights in the occupied Crimea. Therefore, meetings were held with representatives of the embassies of the US, Great Britain, Lithuania, Latvia, the EU, Slovenia and the Czech Republic.

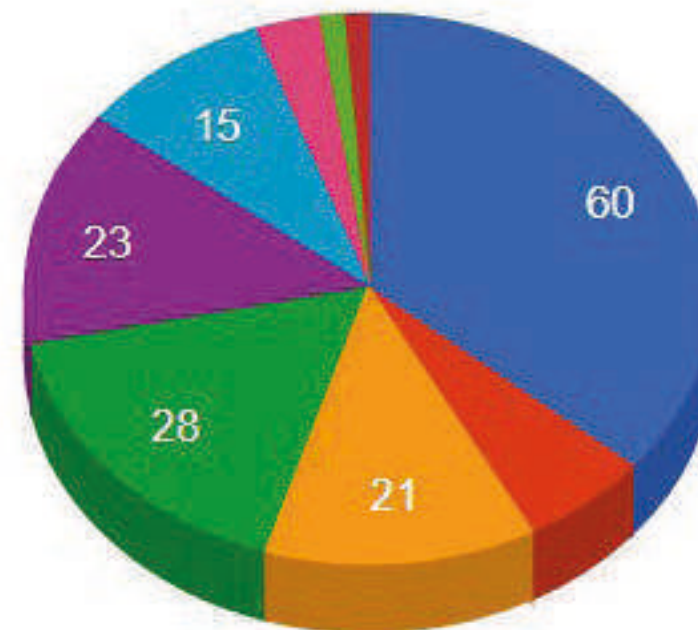
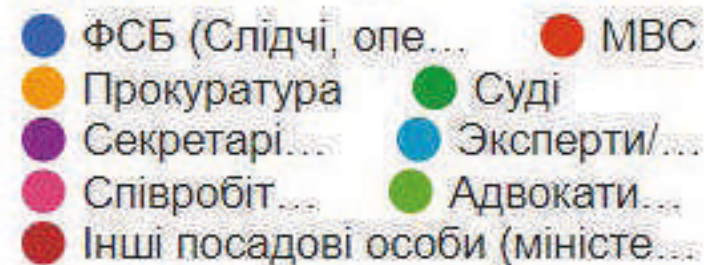


DIAGRAM «PERSONS WHO VIOLATE

In 2021, the Crimean Tatar Resource Center presented an analytical report «Analysis of the situation in the occupied Crimea as of 2020». In this document, CTRC experts revealed the main trends, dynamics and number of offenses on the peninsula during the period of occupation of Crimea. The analysis was developed in two languages: Ukrainian and English and was sent to all embassies of foreign countries in Ukraine.



ANALYSIS OF THE SITUATION IN THE OCCUPIED CRIMEA IN 2020

INDIVIDUAL RIGHTS | Abduction of people 7

A total of 55 people died during the occupation, given that these people were victims of crime, for various reasons, the Crimean Tatar Resource Center has developed a Classification of «Victims of the occupation of Crimea». It consists of four categories: Victims of political repression, Victims of discrimination, Victims of terror, Victims of police abuse:

The first group includes people who were socially active and opposed the actions of the occupation structures, which was the cause of their deaths. The second group includes representatives of the Crimean Tatar people and ethnic Ukrainians, the circumstances of their death remain unknown. The third group includes victims of the Kerch terrorist attack on October 17, 2018, as well as victims of violent death. The fourth group includes people who died from the actions of representatives of the so-called law enforcement or in jail.

Abduction of people

The practice of abduction and disappearance of people who have an active civil position has become regular. As of March 13, 2020, there is no reliable information about the whereabouts of a 38-year-old **Marlen Shevketov**. As of April 28, 2020, there is no reliable information about the whereabouts of a minor **Kateryna Kalaspova** from Simferopol. According to the Liza Alert search and rescue team, as of June 24, 2020, there is no reliable information about the whereabouts of a 41-year-old **Shevket Aripov**.

In 2014, 8 people went missing on the territory of the occupied Crimea, in 2015 — 4 people, in 2016 — 4 people, in 2019 — 2 people, in 2020 — 3 people. So far there is no information about them, this is a violation of Articles 1, 2, 3, 28, 30 of the Universal Declaration of Human Rights, Articles 2, 5, 14, 17, 18 of the European Convention on Human Rights, Article 1 of Protocol No.32 and Articles 1, 2, 7, 9 of the UN Declaration on the Rights of Indigenous Peoples.

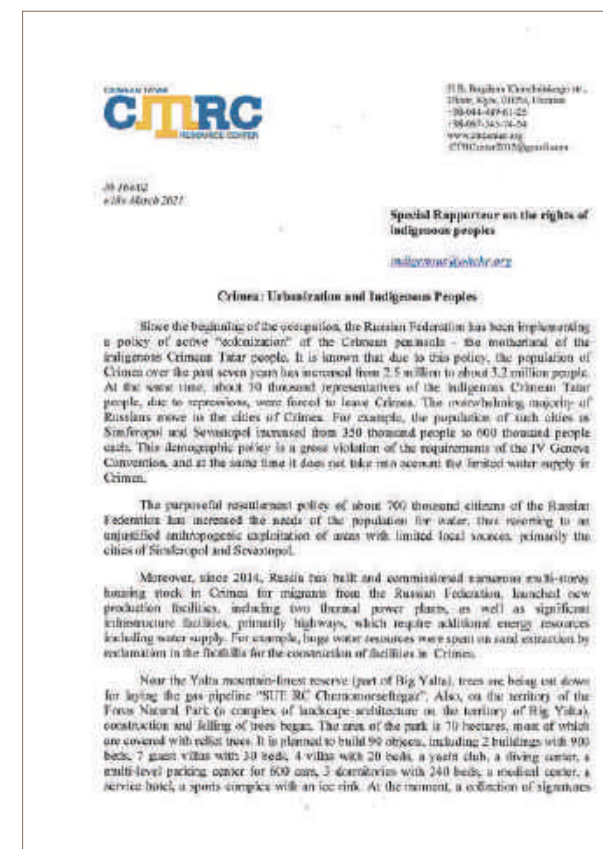

6.2. PROTECTION OF COLLECTIVE RIGHTS OF THE CRIMEAN TATAR PEOPLE

In 2021, CTRC sent its report «Crimea: Urbanization and Indigenous Peoples» to the UN Special Rapporteur on the Rights of Indigenous Peoples as part of the study on the Rights of Indigenous Peoples Living in Cities. Two pieces were sent to the UN Permanent Forum on Indigenous Peoples: «Climate Change and indigenous peoples» and «International Decade of Indigenous Languages 2022 – 2032». A report was sent to the UN Special Rapporteur on the promotion and protection of human rights and fundamental freedoms in the context of the fight against terrorism: «Persecution of the indigenous Crimean Tatar people in the occupied Crimea under the guise of fighting terrorism» as part of the research, the report «Persecution and violence against women in the occupied Crimea» was sent to the UN Committee on the Elimination of Discrimination against Women as part of the general discussion on the topic «Rights of Indigenous Women and Girls».

On July 21, 2021, the President of Ukraine Volodymyr Zelensky signed the Law of Ukraine «On Indigenous Peoples of Ukraine» which was initiated by him and adopted by the Verkhovna Rada of Ukraine on July 1, 2021. For many years, CTRC advocated the adoption of this document, and now the organization's experts are actively involved in the process of developing by-laws in accordance with this new Law.

The Crimean Tatar Resource Center translated the law of Ukraine «On the indigenous peoples of Ukraine» into English, Spanish, and French and sent it to the world's leading experts in the field of indigenous peoples rights to receive expert opinions.

6.3. RECOGNITION OF THE 1944 DEPORTATION AS AN ACT OF GENOCIDE

In 2021, cooperation with other countries regarding the recognition of the deportation of the Crimean Tatar people as an act of genocide continued along two lines: political and legal recognition (court decision).

Four meetings were held with the representatives of foreign embassies in Ukraine, packages of documents were handed over with an appeal to recognize the deportation of 1944 as an act of genocide. In total, CTRC is working with 36 countries to recognize the deportation as an act of genocide.

CTRC supports the investigation of criminal proceedings by the Prosecutor's Office of the Autonomous Republic of Crimea regarding the legal recognition of the deportation of 1944 as an act of genocide.

6.4. THE #LIBERATECRIMEA MOVEMENT

Participants of the #LIBERATECRIMEA international civil society movement for the de-occupation of Crimea and solidarity with the Crimean Tatar people held 16 campaigns, events, pickets and flash mobs in various cities around the world and Ukraine with a call to join efforts for the de-occupation of Crimea, restoration of Ukraine's territorial integrity, protection of human rights in the occupied Crimea, implementation of the collective rights of the Crimean Tatars in their historical homeland.

On February 26, rallies were held in Melitopol and Vinnytsia to mark the Day of Resistance to the Russian Occupation of Crimea. Activists unfurled posters developed by the Crimean Tatar Resource Center and #LIBERATECRIMEA activists as part of the campaign «Does it hurt?» with the inscriptions: «Does it hurt?», «Deputy, does it hurt?», «You are in my heart!», «Deputy, help the political prisoners of the Kremlin!».

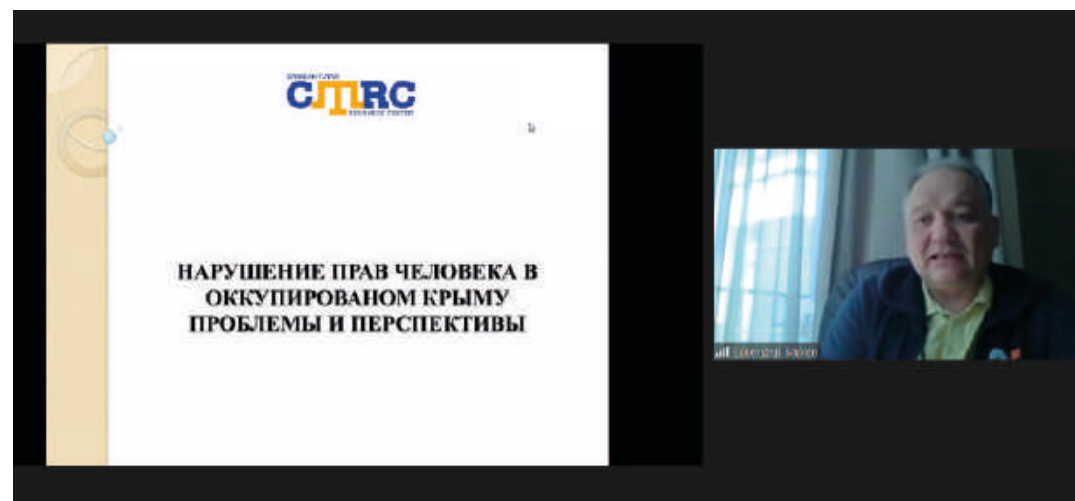
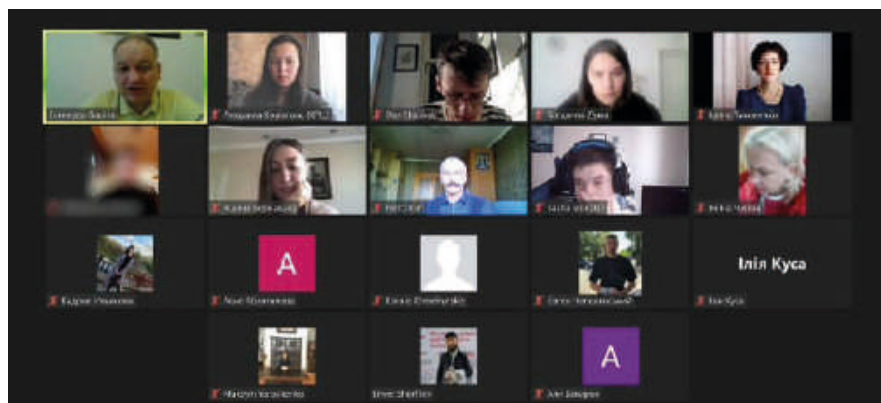
6.5. EDUCATIONAL ACTIVITY

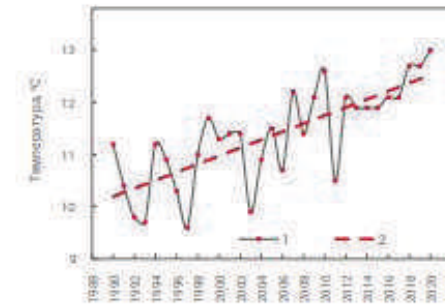

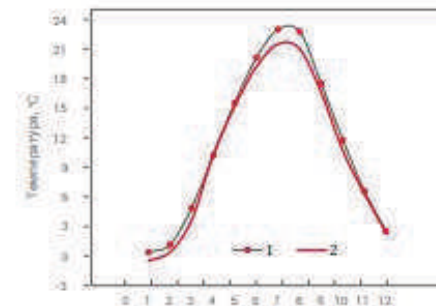

Річна сума атмосферних опадів на метеостанції Сімферополь за період 1990-2020 рр. становить близько 498±32 мм/рр (при кліматичній нормі 505±93 мм/рр). А за останні ~30 років зафіксовано зменшення кількості атмосферних опадів на 14 мм/рр за 30 років (на 5-7% за період спостережень) (див. табл. 3, рис. 4).

Сезонний хід суми атмосферних опадів на метеостанції Сімферополь має чітко виражений максимум у червні-липні (56-45)±26 мм/міс, а в січні-лютому – 140-42)±21 мм/міс. В теплий період року (липень-вересень) у вигляді дощу випадає 295±48 мм, а у холодний період (жовтень-березень) – 210±75 мм (див. рис. 5 та табл. 2). Протягом року кількість днів з дощем становить 116, а зі снігом – 34.

The experts analyzed the state of the environment and the technogenic situation on the peninsula, and also discussed the issues of ecology and sustainable development of Crimea in the context of the «Crimea Platform».

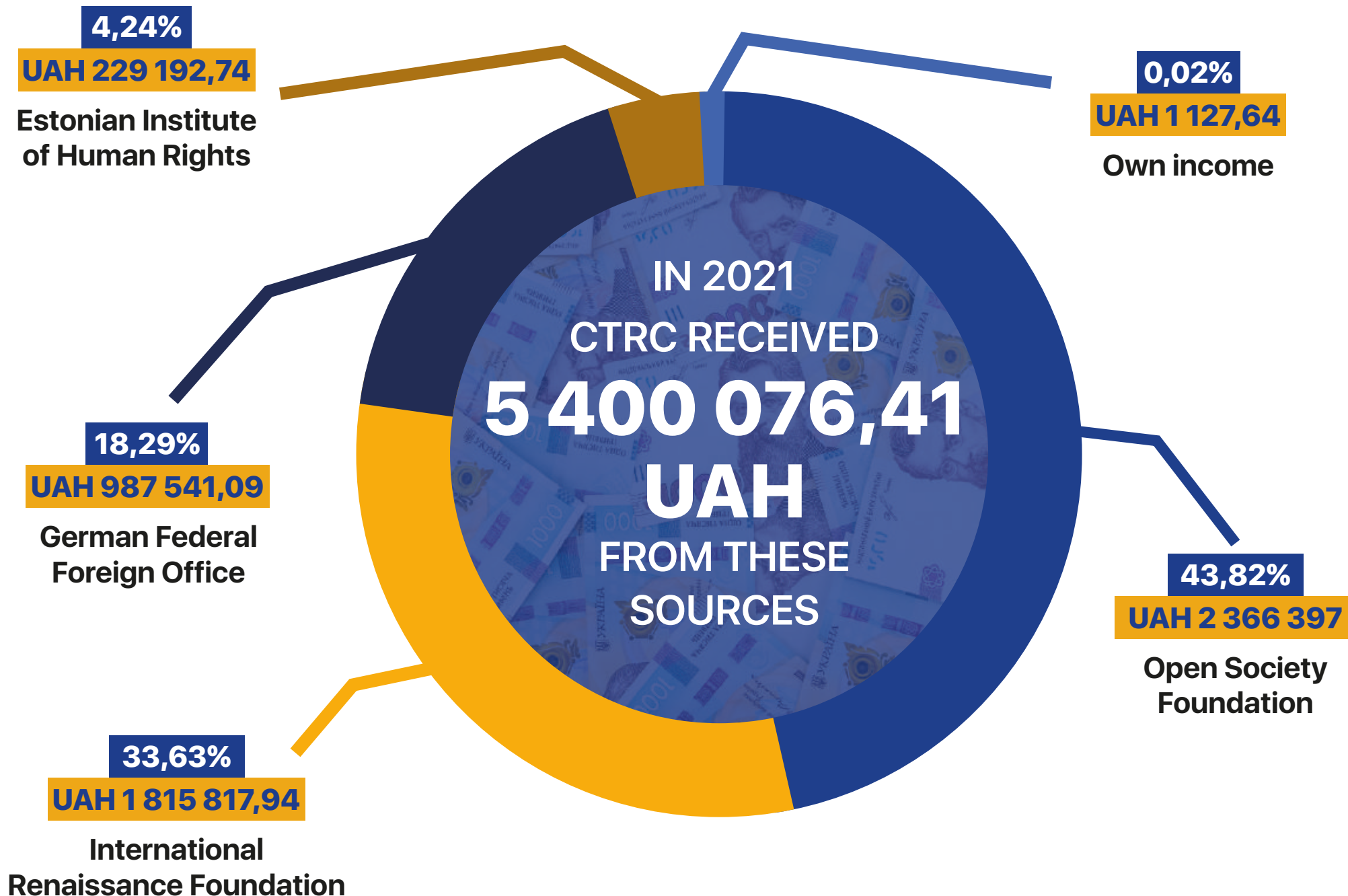

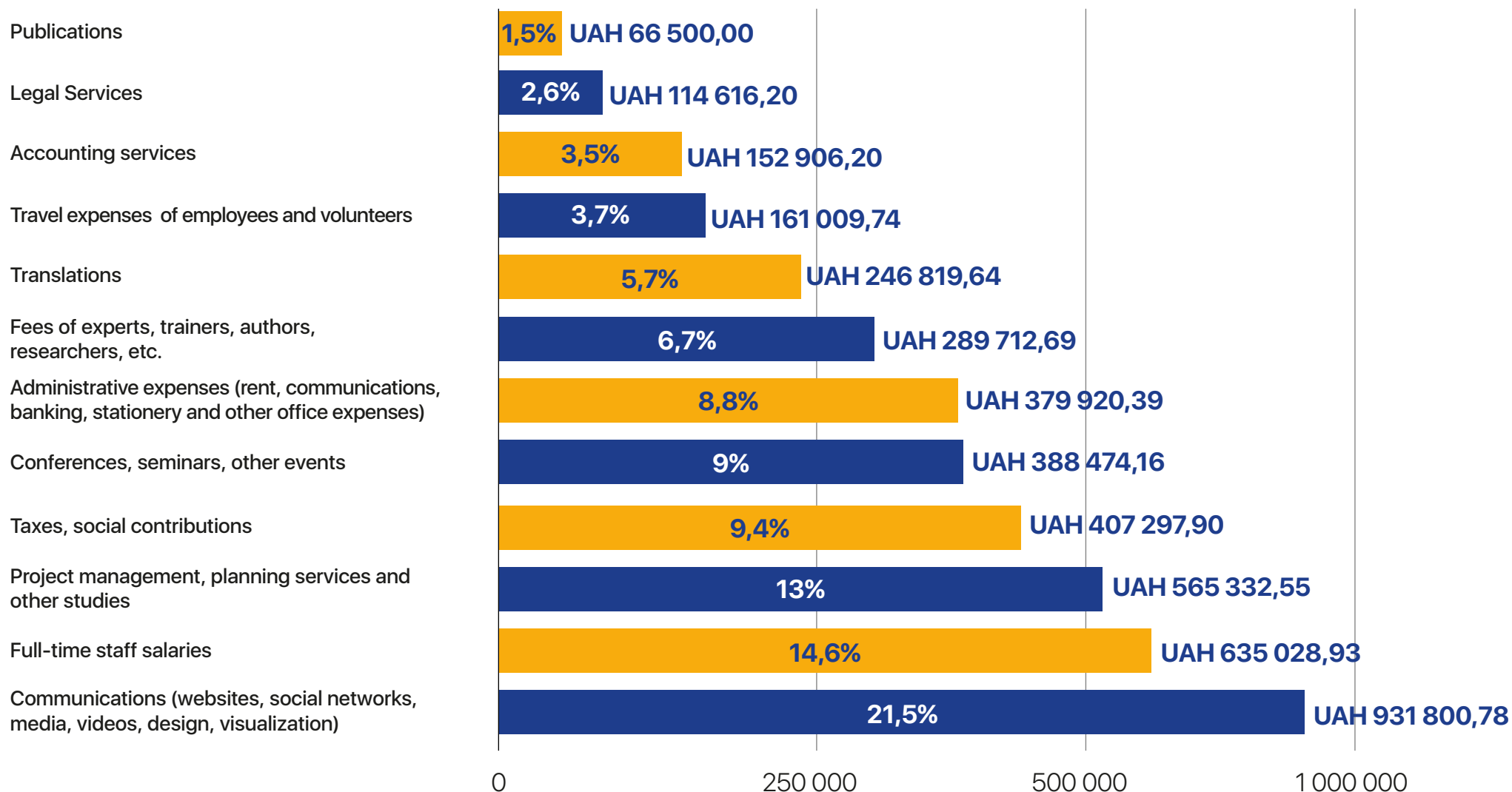
